of the following conditions:

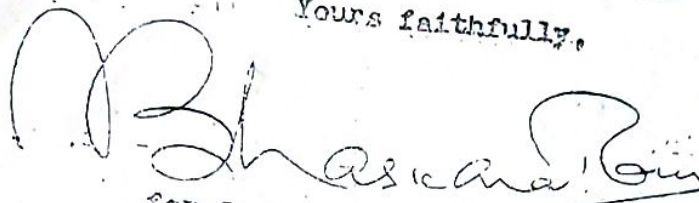
- i) This State Government reserves the right to

- ii) Admissions should be made with bonafide date
of birth certificates;
- iii) All the untrained teachers should be replaced
by trained teachers;
- vi) To collect the tuition fee and special fee etc.
as prescribed by Government of Andhra Pradesh

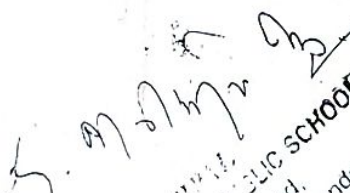

- vi) The School management should follow the rules that are in force in Andhra Pradesh State;
- vii) The District Educational Officer or his nominee should be invited when the management makes recruitment of candidates for various categories of posts;

- ix) The management should not collect donations either from students or parents for admissions.
- x) Staff salaries should be paid as per Govt scales of pay.
